Recommendation:

That the Traffic Commission:

- a1) Recommend that the City Council find that vehicles parking on Weatherwood and Springwood “substantially interfere with the normal and expected use of available public street parking spaces at regular daily or weekly intervals”, establish a parking permit district on Weatherwood and Springwood from 10:00 PM to 6:00 AM and remove the existing overnight parking restriction signs on Weatherwood and Springwood; and
- b1) Recommend that that the City Council adopt Resolution No. 2018-xxx1 “Resolution of the City Council of the City of Laguna Niguel, California Establishing a Permit Parking District on Weatherwood and Springwood and Establish a Bail Amount for Permit Parking Violations on Weatherwood and Springwood”.

OR

- a2) Recommend that the City Council find that vehicles parking on Alderwood, Bentwood, Burntwood, Fallen Oak, Hiddenwood, Orange Oak, Rainwood, Rustic Oak, Shadywood, Spindlewood and Weatherwood and Springwood “substantially interfere with the normal and expected use of available public street parking spaces at regular daily or weekly intervals”, establish a parking permit district on the above mentioned streets from 10:00 PM to 6:00 AM and remove the existing overnight parking restriction signs on Weatherwood and Springwood; and
- b2) Recommend that that the City Council adopt resolution No. 2018-xxx2 “Resolution of the City Council of the City of Laguna Niguel, California Establishing a Permit Parking District on Alderwood, Bentwood, Burntwood, Fallen Oak, Hiddenwood, Orange Oak, Rainwood, Rustic Oak, Shadywood, Spindlewood and Weatherwood and Springwood (except in front of Public Park) and Establish a Bail Amount for Permit Parking Violations on Alderwood, Bentwood, Burntwood, Fallen Oak, Hiddenwood, Orange Oak, Rainwood, Rustic Oak, Shadywood, Spindlewood and Weatherwood and Springwood (except in front of Public Park)” and remove the existing overnight parking restriction signs on Weatherwood and Springwood; and
- c) Recommend that the City Council direct Police Services to continue to provide parking enforcement as time and personnel permits.
