No action will be taken on any items not on the agenda, unless the City Council makes a determination that an emergency exists or that there is a need for immediate action and the need to take action came to the attention of the City subsequent to the agenda being posted. Any documents pertaining to items on the agenda that are provided to the City Council prior to 2:00 p.m. on the day of the City Council meeting will be available for public review at the counter that is located inside the Council Chambers.


